

**NOTICE OF PUBLIC HEARING TO
RECEIVE PUBLIC COMMENT ON THE
PROPOSED CHANGES TO GOLDEN GATE TRANSIT BUS ROUTES AS IDENTIFIED
IN THE MARIN-SONOMA COORDINATED TRANSIT SERVICE (MASCOTS) PLAN**

NOTICE IS HEREBY GIVEN that the Golden Gate Bridge, Highway and Transportation District (District) will hold a Public Hearing to receive public comment, as follows:

The District is proposing to modify Golden Gate Transit (GGT) bus routes, as recommended in the Marin-Sonoma Coordinated Transit Services (MASCOTS) Plan, with the understanding that Board policy requires that a public hearing be held for service changes that affect 25% or more of the revenue service mileage of a route or result in the discontinuation of a route. All proposed service changes described in all relative staff reports will be included in the public outreach prior to the public hearing, even if they do not meet the threshold.

MASCOTS is a proposal to grow ridership and improve effectiveness of public transit services offered in the Highway 101 corridor. This is a collaborative project among nine North Bay transit and funding agencies to create a more connected, frequent transit network. The MASCOTS Plan proposes routing and/or schedule changes to Routes 101, 130, 172, 580, and 580X and the discontinuation of Routes 150, 164, and 172X.
