### Position Summary

Under supervision, carries out all deck work normally performed by deckhand aboard District passenger vessels, including watch, and related duties as required.

### Essential Responsibilities

- Performs tying up and letting go of the vessel, and rigging gangways as required.
- Responsible for assisting passengers boarding and debarking, and watching out for the safety of the passengers and boat.
- Performs passenger count when required and collecting tickets when required.
- Responsible for carrying out light sanitary duties such as sweeping; mopping spills; washing windows; cleaning off chairs, tables and benches; vacuuming carpets; wiping off paint work (spot); emptying trash receptacles and replacing liners; connecting sewage line as necessary; taking fresh water and assisting with fueling as needed; and hosing down outside decks and ship's side which includes washing with pressure washer.
- Maintains toilet supplies as needed and keeping toilet spaces hygienic and in useable condition.
- Performs heavy sanitary work such as: complete mopping of toilet decks; washing down outside decks, bulkheads or overheads with soap or detergent solution from a bucket and rinsed off; washing interior bulkheads and overheads with soap or detergent solution from a bucket and rinsed off; scrubbing mats; thoroughly cleaning and disinfecting any deck area, carpeting, bulkhead or surface which has been contaminated with vomit, excrement, or other offensive substance; and thoroughly cleaning and disinfecting the insides of trashcans and permanent (rigid) trash can liners by hand.
- May assist in some maintenance work as needed.
- May act as watch person on shift as assigned.
- Knows and follows the safety and health rules and safe working practices applicable to his or her job.
- Establishes and maintains effective working relationships with District employees, customers, vendors and all others contacted during the course of work using principles of excellent customer service.



- Performs additional related duties as assigned.
- Regular and reliable attendance and performance is required.

## Required Knowledge, Skills and Abilities

### Knowledge of:

- District Policies and Labor Agreements (MOUs).
- Occupational health and safety rules and working practices applicable to this position.

### Skill in or Ability to:

- Communicate effectively with the general public.
- Understand and carry out oral and written instructions.
- Work cooperatively with other District employees and the public.
- Assimilate and carry out emergency instructions and procedures as directed by vessel operator.
- Understand and carry out safe work practices.

## Minimum Qualifications

**Education and/or Experience:** Marine experience/background is desirable.

**Physical Requirement:** Work outside in all weather conditions. Stand, walk, or brisk walk for long periods of time. Ability to run. Keep or regain the body's balance. Lifting and carrying up to 50 pounds; climbing rung ladders; frequent climbing of stairs; twisting and reaching over-head; bending; pushing and pulling heavy loads; stooping and gripping. Work around chemicals, fumes, odors, and dust in an occasionally high noise level environment with appropriate personal protective equipment. Must be able to respond to emergency situations while aboard vessel including firefighting (dragging a fire hose 150'). Assisting in the rescue of a passenger overboard and assisting passengers, and other vessels in general rescue operations.
